**USCIS added a new \$600 "Asylum Program Fee" to be paid by all petitioners (except for small employers and nonprofits) filing Form I-129 nonimmigrant petitions and Form I-140 immigrant visa petitions.

***USCIS added a new \$300 "Asylum Program Fee" to be paid by petitioning small employers (25 or fewer full-time equivalent employees) filing Form I-129 nonimmigrant petitions and Form I-140 immigrant visa petitions; there is no "Asylum Program Fee" for IRC § 501(c)(3) nonprofit petitioners.
